### **Directions**

Add one (1/2 oz.) premeasured packet per gallon of water. Powdered Detergent/Disinfectant is EPA registered as a disinfectant. This product has demonstrated efficacy against a variety of microorganisms including Pseudomonas aeruginosa PRD-10, Escherichia coli, Klebsiella pneumoniae, Salmonella schottmuelleri, Salmonella choleraesuis, Brevibacterium ammoniagenes, Streptococcus faecalis, Shigella dysenteriae, Staphylococcus aureus, Enterobacter aerogenes, Trichophyton mentagrophytes, and HIV-1. As an EPA registered disinfectant, it is a violation of federal law to use this product in a manner inconsistent with its labeling.
